### SIG Event Big Data Analytics

In view of the 2024 ESWRA Conference Theme Envisioning Future: Social Work Research and Discourse in the Age of Industry 4.0 featuring technological innovations in social work and social work research we were delighted to welcome Professor Brian Taylor and Dr Beth Coulthard Ulster University to our pre-conference SIG Event. Beth's presentation commenced with a somewhat challenging proposition;

Artificial intelligence (the robot!) WILL steal your job! Using an interactive and engaging style, interjected with quizzes and videos Beth led us through this challenging proposition exploring pros and cons.

It is evident AI can assist users in all phases of the big data cycle, or the processes involved in the aggregation, storage, and retrieval of diverse types of data from various sources. These include data management, pattern management, context management, decision management, action management, goal management, and risk management. But like all good debates and research discussions the answer is inconclusive. It will like so many things have its proponents and its opponents. The answer will lie somewhat in the middle.

As convenor and Newsletter editor I am using my privilege to add a comment. "As a newcomer to the whole debate on AI, I appreciate that I really need to better understand it. In the meantime, I am prepared to admit AI has a role when applied sensibly and thoughtfully by subjectmatter experts. By that I mean people with longstanding experience with the problem that they are trying to solve. Deciding what to predict and how to frame those predictions is frequently the most challenging aspect of applying AI - Despite extensive talk of algorithms and big data. Likewise, subject expertise will be required to know if models will continue to work in the future, be accurate on different populations, and enable meaningful interventions".

Dr Siddhartha Baviskar, Ph.D., is Associate Professor at the Institute of Social Work, University College Copenhagen, Denmark. He is currently leading a feasibility study of the intervention *Me and My Foster Family II* (MOMP2) in two Danish municipalities.
